BYLAW NO. 2024-02

A BYLAW OF THE TOWN OF CRAIK TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY THE WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

Council of the *Town of Craik*, in the Province of Saskatchewan, enacts as follows:

- 1. The charges to be paid by the assessed owner whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
- 2. The assessed owner of the premises drained or that are by bylaw required to be drained into the sewer shall pay for such services by a rental rate or service charge in accordance with Schedule "B" attached.
- 3. Accounts for water and/or sewer service shall cover a period of three successive months, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid or payment arrangements accepted, together with a fee of \$30.00 to cover the expenses of turning off the water and turning it on again.
- 4. A penalty of 3.00% per month will be added to all water and sewer accounts outstanding 30 days after billing date.
- 5. Bylaw No. 2022-01 is hereby repealed.

6. **THE** rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government

Committee.
