- 1. LMR and Town of Craik split the LMR interest charges 50/50 on all overdue signal maintenance invoices.
- 2. Town of Craik reduce its outstanding grass cutting invoices to \$1200 per year, (2 cuts @ 8 hrs @at a rate of \$75/hr
- 3. Town of Craik remove the interest charges on all years prior to the March, 2015 invoice
- 4. LMR and Town of Craik split the interest charges 50/50 on overdue invoice for March 2015 until now for grass cutting at the \$1200 per year rate
- LMR agree to handle Mp71.36 as 50/50 surface maintenance cost same as the other crossing, not already covered by board order (does not include signalized crossing MP 71.81
- LMR will maintain culverts, brush cutting and rodent control to Craik bylaw standards.
- 7. LMR will be responsible for grass cutting to Town of Craik bylaw standards
- 8. LMR will respond and take appropriate remedial action to concerns raised by Town of Craik concerning LMR properties within the Town of Craik.
- 9. Each entity will pay monies owing to the other in a timely fashion.
