


### **A BYLAW TO PROVIDE FOR THE MUNICIPALITY TO ENTER INTO AN AGREEMENT TO AN AGREEMENT WITH THE CRAIK AND DISTRICT REGIONAL PARK**

The Council of the Town of Craik in the Province of Saskatchewan enacts as follows:


1. In this bylaw:
  - a. "Administrator" shall mean the administrator of the municipality;
  - b. "Council" shall mean the council of the municipality;
  - c. "Head of council" shall mean the mayor or reeve of the municipality, as the case may be;
  - d. "Municipality" shall mean the Town of Craik;
2. The Town of Craik is hereby authorized to enter into an agreement with The Craik and District Regional Park for the purpose stated within the agreement.
3. The agreement is attached hereto and forms a part of this bylaw, and is identified as "Exhibit A".
4. The head of council and the administrator are hereby authorized to sign and execute the agreement described as Exhibit A.

**CRAIK AND DISTRICT REGIONAL PARK**

THIS AGREEMENT made this 1st day of January A.D. 2020

BETWEEN

**CRAIK AND DISTRICT REGIONAL PARK AUTHORITY**

the party of the second part

-and -

**THE TOWN OF CRAIK**, a municipal corporation of and in the Province of Saskatchewan,  
hereinafter referred to as "Town of Craik"

the party of the second part

-and -

**THE RURAL MUNICIPALITY OF CRAIK, NO. 222**, a municipal corporation of and in the Province  
of Saskatchewan, hereinafter referred to as "The R.M. of Craik"

the party of the third part

-and -

**THE RURAL MUNICIPALITY OF ARM RIVER, NO. 252**, a municipal corporation of and in the  
Province of Saskatchewan, hereinafter referred to as "The R.M. of Arm River"

the party of the fourth part

-and -

**THE RURAL MUNICIPALITY OF SARNIA, NO. 221**, a municipal corporation of and in the Province  
of Saskatchewan, hereinafter referred to as "The R.M. of Sarnia"

the party of the fifth part

-and-

**THE RURAL MUNICIPALITY OF HURON NO. 223**, a municipal corporation of and in the Province  
of Saskatchewan, hereinafter referred to as "The R.M. of Huron"

the party of the sixth part

WHEREAS the parties named above desire to continue to associate with each other for the purpose of further developing and maintaining the Regional Park known as **THE CRAIK AND DISTRICT REGIONAL PARK** established under The Regional Parks Act, 1979 and the parties wish to make financial contributions in the amounts stated in this agreement for a further three-year period.

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of these presents and the covenants, promises, and agreements hereinafter contained, the parties jointly and severally agree as follows:

1. TO CONTINUE to associate and work together and appoint representatives to THE CRAIK AND DISTRICT REGIONAL PARK AUTHORITY to further develop, operate and maintain THE CRAIK AND DISTRICT REGIONAL PARK. The municipalities shall appoint the following number of representatives to the Regional Parks Authority:

Town of Craik - a maximum of three representatives

R.M. of Craik -- a maximum of three representatives

R.M. of Arm River - a maximum of two representatives

R.M. of Sarnia - a maximum of two representatives

R.M. of Huron - a maximum of two representatives

The parties may contact the Board for assistance in finding representatives to sit on the board.

2. TO CONTINUE to develop, operate and maintain that area of land now designated as the **CRAIK AND DISTRICT REGIONAL PARK** and more particularly described as follows:

All that portion of the North West Quarter of Section Twenty-four (24) in Township Twenty-four (24) in Range Twenty-eight (28) West of the Second Meridian, in the Province of Saskatchewan, in the Dominion of Canada as Parcel "A" Plan No. 72MJ14586.

All that portion of the North West Quarter of Section Twenty-four (24) in Township Twenty-four (24) in Range Twenty-eight (28) West of the Second Meridian, Saskatchewan described as follows: Commencing at the South West

corner of the Quarter section; thence Northerly along the Western boundary 1390 feet; thence Easterly parallel with the Southern boundary 1535 feet; thence Southerly parallel with the Western boundary to the Southern boundary; thence Westerly along the Southern boundary to the point of commencement.

Except: Firstly: all that portion for the Roadway on Plan 69MJ08822

Secondly: Parcel A on Plan 72MJ14586

All that portion of the South West Quarter of Section Twenty-four (24), in Township Twenty-four (24) in Range Twenty-eight (28) West of the Second Meridian, Saskatchewan described as: Commencing at a point on the North boundary of the Quarter Section 350 feet Easterly thereon from the North West corner thereof: thence Easterly along the North boundary 1235 feet; thence Southerly perpendicular to the North boundary 170 feet; thence Westerly parallel with the North boundary 1235 feet; thence Northerly to the Point of commencement.


3. THE PARTIES each agree to provide bylaws authorizing annual contributions to the **CRAIK AND DISTRICT REGIONAL PARK** in the following proportions:

<b>MUNICIPALITY</b>	<b>ANNUAL CONTRIBUTION</b>
Town of Craik	Six Thousand Dollars (\$6000.00)
R.M. of Craik No. 222	Ten Thousand Dollars (\$10,000.00)
R.M. of Arm River No. 252	Two Thousand, Two Hundred (\$2200.00)
R.M. of Huron No. 223	One thousand Dollars (\$1 000.00)
R.M. of Sarnia No. 221	Sixteen Hundred Dollars (\$1 600.00)


4. THE PARTIES agree to perform and do all acts necessary to ratify and confirm this agreement and the parties agree to pass a complementary bylaw authorizing the execution and performance of this agreement.

5. THIS AGREEMENT shall be renewable at the end of three years should the municipalities participating under this agreement so desire.


